IMPORTANT – SCHOOL DANCE AHEAD



- Students need a signed permission form to attend the dance. Please return the signed form to your teacher
- Only students who attend Buckingham Elementary School and their brother/sister are permitted to attend this school Christmas dance.
- Child(ren) drop-off and pick up is the responsibility of the parents / guardians. Custodial arrangements must be made prior to the dance. Volunteers will not be involved in any custodial issues.
- **Parents / guardians must come inside the school to drop off and pick up the child(ren). Parents/guardians must sign the child(ren) “in” and “out”.** Students will not be allowed to leave the school premises without a parent/guardian. ***Students from K – Grade 3 MUST be accompanied by a parent/guardian***
- Dance is managed by the chief chaperone
- At the beginning of the dance, chaperones will be identified. They include members of the Parent Participation Organization (PPO) and other volunteers.
- Chaperone instructions are to be respected by everyone.
- The Chief Chaperone has the right to request anyone judged to be behaving inappropriately to leave the school or to refuse to admit someone who has no right to be in attendance. If a student is asked to leave the dance, the emergency contact name will be called.
- Parents and children are to be respectful and non-abusive to Parent Participation Organization (PPO) Members and Volunteers.
- Doors will be monitored by a Parent Participation Organization (PPO) and Volunteers.
- School access is limited to the gym (dance area), lobby and washrooms on the main floor.
- No smoking or alcoholic beverages permitted at the dance or on school grounds.
- Safety / emergency measures in place for the dance are working in conjunction with the school’s Emergency Preparedness Plan.

Volunteers must have a valid Security Background Check recognized by the school
